NOTICE

In accordance with the UGC Guidelines on Examinations and Academic Calendar in view of the COVID-19 Pandemic-July 2021 (vide D.O. F.1-1/2021 (Secy) Dated, 16.07.2021), the modalities of the Intermediate Semester / Year Examinations, 2021 at the UG level adopted in the meeting of the Executive Council (EC) of University of Gour Banga, Malda held on August 24, 2021, proposed by the Examination Monitoring Committee (vide Ref. No.: 369/UGB/CE-2021, dated: August 12, 2021), are notified for all concerned as follows:

a. For UG Part-I and Part-II (Honours and General) Examinations, 2021]

- The results for the UG Part-I and Part II (Honours and General) Examinations, 2021 will be finalized on the basis of the guidelines issued by the UGC, where paper wise 50% Weightage will be considered on the basis of the (subject wise) percentage obtained by the candidate of the previous year (i.e. Part-I for the examinees of Part-II Examinations) and 50% weightage on Internal Evaluation (to be conducted by the concerned college) during the current year, irrespective of the nature and type of the course / subject / paper.
- In the situations where previous year marks are not available, particularly in the first year of annual pattern of examinations (i.e., UG Part I Examination), 100% evaluation may be done on the basis of internal evaluation.
- The mode and nature of the Internal Evaluation will be decided by the concerned College Principal / TIC / OIC and the concerned College Principal / TIC / OIC will take responsibility for the submission of the obtained marks of the Internal Evaluation of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).

b. For UG 2nd Semester and 4th Semester (Honours and General) Examinations, 2021

- The results for the UG 2nd and 4th Semester (Honours and General) Examinations, 2021 will be finalized on the basis of the guidelines issued by the UGC, where course wise 50% Weightage will be considered on the basis of the (subject wise) percentage obtained by the candidate of the previous semester (i.e. 1st semester for the examinees of 2nd semester examination and 3rd semester for the examinees of 4th semester examination) and 50% weightage on Internal Evaluation (to be conducted by the concerned college) during the current semester, irrespective of the nature and type of the course / subject.
- In the situations where previous semester or previous year marks are not available, particularly in the SEC-2(B1) course for 4th semester examination, 100% evaluation may be done on the basis of internal evaluation.
- The mode and nature of the Internal Evaluation will be decided by the concerned College Principal / TIC / OIC and the concerned College Principal / TIC / OIC will take responsibility for the submission of the obtained marks of the Internal Evaluation of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).

c. For Professional UG Degree Courses (Like - B.A. LL.B. and B.C.A.) [Intermediate Semester Examinations, 2021]

- The results for the Intermediate semesters for any professional under graduate courses will be finalized on the basis of the guidelines issued by the UGC, where paper wise 50% Weightage will be considered on the basis of the (subject wise) percentage obtained by the candidate of the previous semester and 50% weightage on Internal Evaluation (to be conducted by the concerned college) during the current semester, irrespective of the nature and type of the course / subject.
- In the situations where previous semester or previous year marks are not available, 100% evaluation may be done on the basis of internal evaluation.
- The mode and nature of the Internal Evaluation will be decided by the concerned College Principal / TIC / OIC and the concerned College Principal / TIC / OIC will take responsibility for the submission of the obtained marks of the Internal Evaluation of the examinees to the Office of the CoE, UGB within stipulated timeframe (as notified by the Office of the CoE, UGB).
